Surely it can't have slipped your notice that I and my fellow councillors have been campaigning for the last few weeks on this issue. We have been in both shopping centres giving out leaflets reminding people to sign the

petition, with every point you have made has been covered. This is a an issue that most Hayling residents feel strongly about and are working together as a team. I do meet with C. Cllr. Rob Humby, the cabinet member who is responsibly for the decision, to express my concerns on the impact this will have on residents. Rob has met 5 MPs from various locations in Hampshire to voice his concerns about the major cutback in Government funding, and is going to London to discuss this further. The loss of 46m is why these cuts are being proposed. I will continue to lobby on our behalf at Winchester until a decision is made.
